ESG APPROACH

- The Global Government Bond Fund uses environmental, social, and governance (ESG) integration as part of its investment process. This means incorporating ESG factors to enhance investment decisions. Our philosophy is that ESG factors are a component of the investment decision—meaning that they are not the sole driver of an investment decision, nor are they considered separately from more traditional analysis.
- The process of ESG integration takes place on two levels: first, with our research analysts as they incorporate environmental, social and governance factors into issuer valuations and ratings; and, second, with the portfolio manager as he balances these ESG factor exposures at the portfolio level. Both the analysts and portfolio manager are able to leverage dedicated, in-house resources to assist them in analyzing ESG criteria.
- Our ESG specialist teams provide investment research on ESG issues at the company level and on thematic topics. Additionally, they have built tools to help proactively and systematically analyze the environmental, social, and governance factors that could impact our investments. The foundation of the analysis is a proprietary flagging tool called the Responsible Investing Indicator Model (RIIM). It covers over 15,000 companies and pulls from data sets that are not in the wheelhouse of traditional financial analysis. These data sets include:
 - ESG performance data (e.g., number of accidents, carbon emissions, strength of whistle-blower programs, etc.);
 - ESG targets (e.g., plans to reduce carbon emissions, increase diversity, etc.)
 - ESG incidents and controversies (e.g., environmental fines paid, local community controversies/protests against a company, etc.)
- The portfolio is constructed based on identifying the best risk/reward opportunities from the global fixed income universe. Key to this is proprietary, bottom-up research that includes the assessment of ESG factors by our analysts, who work in collaboration with dedicated ESG specialists. We complement this approach with regular screening of the portfolio using RIIM. This helps us understand the ESG characteristics of the portfolio and makes us aware of any elevated exposures to specific ESG factors from a risk management perspective.
- The fund is classified as Article 8 according to the Sustainable Finance Disclosure Regulation. Although the fund does not have sustainable investment as an objective, the promotion of environmental and social characteristics is achieved through the fund's commitment to maintain at least 50% of the value of its portfolio invested in issuers and/or securities that are rated as 'Green' by the T. Rowe Price proprietary Responsible Investor Indicator Model (RIIM). The fund applies the T. Rowe Price RIIM Rating Criteria. The fund avoids issuers whose activities we may consider harmful to the environment and/or society through the application of our proprietary screen, the T. Rowe Price Responsible Exclusion List.

INVESTMENT OBJECTIVE: The fund seeks total return through a combination of income and capital appreciation.

INVESTMENT PROCESS: The fund is classified as Article 8 under SFDR (the EU's Sustainable Finance Disclosure Regulation); it promotes, among other characteristics, environmental and/or social characteristics and the companies in which the investments are made follow good governance practices. The fund is actively managed and invests mainly in a portfolio of bonds issued by governments, government-related entities and government agencies around the world, including emerging markets. Although the fund does not have sustainable investment as an objective, the promotion of environmental and/or social characteristics is achieved through the fund's commitment to maintain at least 50% of the value of its portfolio invested in issuers and/or securities that are rated as 'Green' by the T. Rowe Price proprietary Responsible Investor Indicator Model (RIIM). In addition to the E/S characteristics promoted, the fund also applies the investment manager's proprietary responsible screen (the T. Rowe Price Responsible Exclusion List). The fund may use derivatives for hedging, efficient portfolio management and investment purposes. The fund may also use derivatives to create synthetic short positions in debt securities and credit indices. For full investment objective and policy details refer to the prospectus. RECENT COMPANY ENGAGEMENTS

We maintain a regular dialogue with the management teams of companies represented across the portfolio. Our investment-driven engagement program frequently identifies targets through our proprietary RIIM analysis, governance screening and analysts' fundamental research. While we engage with companies in a variety of different contexts, ESG engagement focuses on learning about, encouraging or exchanging perspectives on the environmental practices, corporate governance or social issues affecting their business.

While most of the meetings we hold with company managements will include some discussion of ESG topics, we differentiate meetings held with a heavy focus on ESG, meaning ESG issues were the sole items on the agenda or made up a meaningful part of the meeting. Agenda items are classified as "meaningful" when they take up a significant portion of the meeting or are a significant factor in the investment case.

The following are selected examples of recent engagements with companies held in or considered for the portfolio. The examples are not meant to be representative of every engagement held, but to illustrate the types of ESG engagements we are having with the managements of our investment companies.

Engagement Outcome	<p>We engaged with representatives of the Canadian federal government as part of a “whole of government” sovereign engagement approach. We also engaged with representatives of the province of Ontario in November 2024.</p> <p>Climate/Natural Disaster Risk With a Focus on Adaptation, Climate Resilience The summer of 2024 now ranks as the most destructive season in Canadian history for insured losses due to severe weather, resulting in combined insurance losses of CAD 7 billion (USD 5 billion) according to the Insurance Board of Canada. The Canadian Climate Institute is unequivocal, that climate change is driving increased extreme flooding and other natural hazards in Canada and beyond. As sovereign and sub-sovereign investors, this increased frequency and severity of climate change-induced natural hazards is a focal area, not least because the severe weather losses in just the summer of 2024 were 10x that of the average experienced in the 2001–2010 period. We provided feedback and reiterated the encouragement previously offered to representatives of Ontario (welcoming the focus the province was arguably beginning to bring to climate adaptation and resilience, including the recent passing of provincial legislation—namely provincial Bill 198, Ontario Climate Change Adaptation and Resilience Act, 2024). The federal government recently announced three major developments in Canada's plans to further promote sustainable investing, namely the development of a new Canadian sustainable investment taxonomy; mandatory climate-related financial reporting for large, federally incorporated private companies; and the issuance of an additional CAD 2 billion in Canadian green bonds. During the meeting, we shared feedback welcoming the progress to date and encouraged the federal government, as appropriate, to work to ensure congruence of its adaptation and resilience plans, with those of the 10 provinces and three territories that constitute Canada.</p> <p>Biodiversity/Natural Capital Empirical research, conducted over a multi-decade period, shows that Canada's forest land has historically been a significant carbon sink. The government of Canada has observed that, due to forest fires and other factors adversely impacting biodiversity, since 1990, the situation has reversed, and Canada's forests are now releasing more carbon into the atmosphere than they are accumulating. The 2023 Canadian wildfires released 640 million tons of carbon into the atmosphere, an amount higher than the total annual carbon emissions of Russia (480 million tons) or Japan (291 million tons). We offered feedback, sharing our focus as sovereign investors, on the role these forests play as nature-based carbon sinks. We encouraged the Canadian sovereign, as appropriate, to consider how incremental investment capital (including through sovereign green bond issuance) and policy support could aid and ultimately incentivize nature net positive (including forestry focused) outcomes.</p> <p>GHG Emissions Reduction At the sovereign level, Canada is the 10th largest absolute sovereign emitter globally and ranks as the ninth largest when viewed on a per capita basis. We shared with the federal government representatives the feedback we had previously offered Ontario, welcoming the province's focus, including through green bond issuance targeting the electrification of the mass transit system in the province.</p>

ESG RIIM PROFILE

The T. Rowe Price Responsible Investing Indicator Model (RIIM) rates companies, governments and securitized assets in a traffic light system measuring their environmental, social, and governance profile and flagging issuers with elevated risks. For certain types of investments, including, but not limited to, cash, currency positions, and particular types of derivatives, an ESG analysis may not be relevant or possible due to a lack of data. Where ESG considerations are integrated into the investment research process, we may conclude that other attributes of an investment outweigh ESG considerations when making investment decisions.

The data in the table below is the RIIM Weighted Average Score which is a combined Environmental, Social and Governance score for the portfolio, and which is used to measure the Sustainability Indicator for the Fund. It differs to the overall RIIM Indicator Score which is determined by the worst of the Environmental, Social and Governance scores.
